MINUTES

ASHE COUNTY BOARD OF EDUCATION

August 3, 2009

The meeting was held at the Ashe County Board of Education Annex as scheduled with Chairman King absent. Vice Chairman Jones called the meeting to order, welcomed those in attendance, and led the Pledge of Allegiance. Vice Chairman Jones gave a special welcome to Dr. Travis Reeves, new Superintendent of Ashe County Schools, and stated that Dr. Reeves will have full support from the Board.

A motion by Dr. Beckworth and a second by Mr. Weaver gave unanimous approval to the agenda following the addition of a transfer request (item 9a), and an amendment to classified personnel (item 17), changing the transfer of Elizabeth Holloway to a resignation.

A motion by Mrs. Witherspoon and a second by Dr. Beckworth gave unanimous approval to the minutes for the regular meeting of the Board on June 30, 2009.

During open comments, Dr. Beckworth commended Amy Walker and the technology staff for a superior Technology Conference that was held in July. Dr. Beckworth also thanked County Manager Dan McMillan and the County Commissioners for their support of level funding for the 2009/10 school year.

Also during open comments, Dr. Beckworth gave thanks to Principal Howell and the excellent way he and the staff at Ashe High handled the honest mathematical error that occurred in the Salutatorian graduation award. Gabriela M. and her family were extremely happy with the celebration in her honor.

Dr. Reeves recognized Dr. Larry S. Taylor, Assistant Professor with the Department of Communication at Appalachian State University, for the exemplary leadership he has shown to the staffs of the *Bulldog Breakdown* (Ashe Middle) and the *Timberwolf Tattler* (Westwood) school newspapers.

Dr. Larry S. Taylor recognized editor Penny Barker of the *Bulldog Breakdown* and editor Tammy Hutchinson of the *Timberwolf Tattler* for their placement of membership in the North Carolina Scholastic Media Association 2009. The *Bulldog Breakdown* received

an overall award ranking of "Distinction", along with "First Place" in *News* and "First Place" in *Sports* awards. The *Timberwolf Tattler* also received an overall award of "Distinction", "Second Place" in *News* and "Second Place" in *Sports*.

CTE Director Joallen Lowder recognized Ashe High school students Daniel F. and Dustin R. for placing 10th at the National Technology Student Association 2009. Mrs. Lowder also recognized their teacher/advisor, Mrs. Thelma Kastl for her leadership.

This project is intended to inspire middle school students to pursue studies and careers in science, technology, engineering, and mathematics. *STEM-ICT 3D* Project Manager Kathy Furr with Appalachian State University presented the outline for the grant.
