MINUTES

ASHE COUNTY BOARD OF EDUCATION

October 4, 2010

The meeting was held at the Ashe County Board of Education Annex as scheduled with all members present except Mrs. Witherspoon who was unable to attend due to illness. Chairman King called the meeting to order, welcomed those in attendance, and led the Pledge of Allegiance.

The agenda for the meeting was approved by general consensus of the Board.

A motion by Dr. Beckworth and a second by Mr. Jones gave unanimous approval to the minutes for the regular meeting of the Board on September 13, 2010.

Superintendent Reeves presented the ACS Employee of the Month Award for October to Mrs. Martha Turner, fifth grade teacher at Blue Ridge.

October *Tech Talk* was presented by Mr. Josh Beckworth, English and Appalachian Studies teacher at Ashe High. Mr. Beckworth discussed the technology used in his class to collect and catalog audio and video data that will be everlasting. Student Chris H. demonstrated how the software program Audacity is used to preserve audio archives from the Public Library for future generations. Student Rachel F. demonstrated how present classroom video interviews are conducted and preserved.

A motion by Mr. Weaver and a second by Dr. Beckworth gave unanimous approval to a request from Ashe High Husky Vanguard Marching Band for an overnight trip to compete at Havelock High School in Havelock, North Carolina, October 30-31, 2010.

A motion by Mr. Jones and a second by Dr. Beckworth gave unanimous approval to a request from Ashe Middle 8th grade for an overnight trip to the Outer banks of North Carolina, April 6-8, 2011.

A motion by Dr. Beckworth and a second by Mr. Jones gave unanimous approval to a request from Ashe High FFA for an overnight trip to attend the National FFA Convention in Indianapolis, Indiana, October 19-23, 2010.

Superintendent Reeves and Curriculum Director Joyce Gardner presented a PowerPoint and shared information regarding *SMART Goals* (Specific, Measurable, Attainable, Results oriented and realistic, and Time-bound) that all directors have been asked to focus on since the July Administrators' Retreat. Teresa Stansberry, Director for Exceptional Children and PreK, was out of town and will present her SMART Goals at the regular November meeting.

Career and Technical Education (CTE) Director Joallen Lowder presented an overview of the CTE Program Comprehensive Review that has been initiated in conjunction with Ashe County Schools Strategic Plan. Mrs. Lowder will present the final CTE Program Review at the December or January regular meeting of the Board.

Ashe County Board of Education Endowment Fund Board of Directors Dr. Calvin Miller and Mr. Ward Sexton presented the revised Endowment Fund Bylaws and Mission Statement. The revised Mission Statement reads: *The Ashe County Board of Education Endowment Fund encourages new and innovative approaches to student learning that are not supported through the traditional funding of public education.*

Superintendent Reeves and Curriculum Director Joyce Gardner presented Ashe County Schools 2010-2012 Strategic Planning Timeline Draft. Superintendent Reeves shared the timeline information and expressed he would like to have the Strategic Plan completed by spring. A motion by Mr. Jones and a second by Dr. Beckworth gave unanimous approval to the timeline with some flexibility if needed.

Superintendent Reeves, Ashe High Principal Jason Krider, and Ashe Middle Assistant Principal Elaine Cox presented information on 2010/11 *Disadvantaged Students Supplemental Funding (DSSF)*. This supplemental funding is to be used to meet the needs of the students in the local administrative unit that are not achieving grade-level proficiency. Ashe High will receive \$67,963 in DSSF monies, and this allotment will be used in areas of cohort graduation rate, EOC testing, discipline/attendance issues, and staff development. Ashe Middle will receive \$38,830 in DSSF monies, and this allotment will be used to target both reading and mathematics. A motion by Mr. Weaver and second by Mr. Jones gave unanimous approval to both DSSF allotments to better serve the students of Ashe County. It was requested by Mr. Weaver that a short recess take place after the following agenda item.

A motion by Mr. Jones and a second by Mr. Weaver gave unanimous approval to renewing the lease with Mrs. Debbie Williams and Learning Thru Play located at the West Jefferson facility. The term of this lease is for five years beginning November 1, 2010, and ending on October 31, 2015.

A short recess was taken.

A motion by Dr. Beckworth and a second by Mr. Weaver gave unanimous approval to adopting a local policy on workers' compensation that aligns with the North Carolina State Board of Education's policy TCS-Q-001, as amended.

A motion by Mr. Jones and a second by Dr. Beckworth gave unanimous approval to the following 2010/11 Budget Resolution.

Superintendent Reeves presented information on *eBOARD*, a web-based program that Board members would use to eliminate paper dependency. After some discussion, the Board agreed not to try this costly program at this time but rather look into other ways the Board could move towards eliminating paper.

Superintendent Reeves and Curriculum Director Joyce Gardner presented information and PowerPoint on North Carolina's *Race to the Top (RttT)* initiative. North Carolina is one of only 12 recipients of the 2010 federal RttT grants, bringing nearly \$400 million to the state's public school system for use over the next four years with the possibility of Ashe County receiving \$400,000 for use over the next four years. After much discussion, Dr. Beckworth agreed to represent the Board along with the RttT team to begin the application process.

A motion by Dr. Beckworth and with no objection, moved consideration of winter and spring coaching assignments at Ashe Middle (item 22) and personnel recommendations (item 23) to follow closed session.
