## ASHE COUNTY BOARD OF EDUCATION

November 1, 2010

The meeting was held at the Ashe County Board of Education Annex as scheduled with all members present. Chairman King called the meeting to order, welcomed those in attendance and led the Pledge of Allegiance.

Following the postponement of two items until the regular meeting of the Board in December, the agenda for the meeting was approved by general consensus of the Board.

A motion by Mr. Jones and a second by Mr. Weaver gave unanimous approval to the minutes for the regular meeting of the Board on October 4, 2010, and the special meeting of the Board on October 13, 2010.

During open comments Superintendent Reeves recognized Mr. A.B. Weaver and thanked him on behalf of students, parents and staff for serving on the Board of Education for the past eight years. Each Board member respectfully thanked Mr. Weaver for his service and dedication.

Superintendent Reeves presented the *ACS Employee of the Month* for November to Mrs. Jackie Marsh, guidance secretary at Ashe High.

November *Tech Talk* was presented by Ms. Colleen Dixon, fifth grade teacher at Mountain View. Ms. Dixon discussed how her students are enjoying math thanks to the iPod Touch. Students Brad C., Lucas P., Lyndsi H., Noah J. and Andrew H. demonstrated the many iPod applications that make fractions, multiplication, division, and Google maps fun and interesting. The students impressed the Board with one-on-one iPod demonstrations.

Relay for Life representative Adam Binder presented the 2010 awards to Superintendent Reeves on behalf of Ashe County Schools "Life Learners" team. Mr. Binder presented the 100% School Participation award, the Rookie Relay Team of the Year award, a Top 10 Team certificate, and a contribution certificate. Mr. Binder stated this was ACS "Life Learners" first year of participation and became one of the top performers and the only team to walk all night. Superintendent Reeves thanked Team Captain Joallen Lowder and all the schools for their dedication to Relay for Life. A motion by Dr. Beckworth and a second by Mr. Weaver gave unanimous approval to a request from Ashe High FFA for an overnight trip to compete in dairy judging at the Rowan County Fairgrounds in Salisbury, North Carolina, November 17-18, 2010.

Ashe County 4-H Extension Agent Jennifer Miller presented the book <u>Secrets of Success</u>, written by General H. Hugh Shelton, to Ashe High library. <u>Secrets of Success</u> is a donation from the North Carolina Agricultural Foundation Inc., the College of Agriculture and Life Sciences and the General Hugh Shelton Leadership Center. This book takes a very special look into leadership and values by featuring leadership experiences from 35 men and women with unique and special North Carolina connection.

Ashe County 4-H Program Associate Linda Blackburn, along with Ashe County Extension Director Carolyn Shepherd and staff, presented information on the afterschool program *IMAGINE* (*Involving*, *Mentoring*, *Achieving Goals*, *In A Nurturing Environment*) offered at the three elementary schools and *LINK* (*Learning*, *Nurturing*, *Inspiring*, *Konnections*) offered at the middle school and the three elementary schools. Mrs. Blackburn stated that 4-H is very proud that it can offer five-star rated programs to the students in the school system.

CTE Director Joallen Lowder introduced Director of Economic Development Dr. Pat Mitchell to present information on the *Golden LEAF Foundation (GLF)* application process to fund *Project Lead the Way (PLW)* at Ashe Middle. Dr. Mitchell stated that the school system received an invitation in September 2010 to submit a Letter of Inquiry (LOI) to the GLF to apply for STEM (Science, Technology, Engineering and Mathematics) education funding. The Foundation received 90 letters of inquiry, and Ashe County was one of the 22 selected to submit a formal application. The entire application will be presented to the Board at its December meeting. The application is due to GLF by December 17, 2010.

Communities In Schools (CIS) Program Coordinator Kendra Perkins presented an update on the CIS program. Mrs. Perkins stated the mission of CIS is to surround students with a community of support, empowering them to stay in school and achieve in life. The CIS mentoring program is for Ashe County students in grades 6-8 that have been identified as a student in crisis due to court involvement, attendance issues, early teen pregnancy, etc. The first CIS training was held October 12, 2010, at which time eleven community mentors were trained. Background checks are in the process of being completed on these mentors. Each student referred by a teacher or counselor must receive permission from their family to participate in the mentoring program. The next mentor training is scheduled for December 7, 2010.

Superintendent Reeves presented information on the *Race to the Top (RttT)* application. Superintendent Reeves stated that the RttT Team has met three times regarding the application process and the local plan is required and due by 5:00 pm November 8, 2010. The main focus of Ashe County Schools' local plan will be on grades K-3 reading. A motion by Mr. Jones and a second by Mr. Weaver gave unanimous approval to the RttT application.
