

## MINUTES

### ASHE COUNTY BOARD OF EDUCATION

April 12, 2010

The April meeting was held at the Board of Education Annex as scheduled with all members present except Mr. Jones due to an out of town appointment and Mrs. Witherspoon due to illness. Chairman King called the meeting to order, welcomed those in attendance, and led the Pledge of Allegiance.

Following the addition of a classified personnel item, the agenda for the meeting was approved by general consensus of the Board.

A motion by Dr. Beckworth and a second by Mr. Weaver gave unanimous approval to the minutes for the regular meeting of the Board on March 1, 2010, and the special meeting of the Board on March 25, 2010.

Superintendent Reeves recognized and presented the Ashe High Varsity Cheerleaders and coach Rachel Shepherd a certificate for being named North Carolina Cheerleading Coaches Association State Cheerleading Champions in the small varsity non-tumble division that took place in Greensboro, North Carolina on February 20, 2010. Superintendent Reeves then presented coach Shepherd and the cheerleaders with a certificate of recognition for being named 2010 CANAM National Cheerleading Champions in the small varsity non-tumble division in Myrtle Beach, South Carolina on March 20-21, 2010.

Superintendent Reeves presented the April *ACS Employee of the Month Award* to Mrs. Drema Farmer, teacher assistant at Blue Ridge.

Superintendent Reeves presented the 2010/11 School Calendar as drafted by the School Calendar Committee. After much discussion, a motion by Mr. Weaver and a second by Dr. Beckworth gave unanimous approval to tabling this item until Mr. Jones and Mrs. Witherspoon are present.

Superintendent Reeves presented an update on the School Based Health Center (SBHC) located at Ashe Middle and the last meeting of the SBHC Advisory Board. Superintendent Reeves was directed by the SBHC Advisory Board to ask the Board of Education to consider a request of \$50,000 to the Ashe County Commissioners. After much discussion and consideration of the request, the Board agreed that all budget requests at this time must focus on educational initiatives due to the current statewide budget crisis and that this request should come from the SBHC Advisory Board. By general consensus of the Board, the request for funding to the Ashe County Commissioners was denied.
