#### MINUTES

#### ASHE COUNTY BOARD OF EDUCATION

May 3, 2010

The May meeting was held at the Ashe County Arts Council as scheduled with all members present. Chairman King called the meeting to order, welcomed those in attendance, and led the Pledge of Allegiance.

The agenda for the meeting was approved by general consensus of the Board.

A motion by Dr. Beckworth and a second by Mr. Weaver gave unanimous approval to the minutes for the regular meeting of the Board on April 12, 2010.

During open comments, Arts Council Director Jane Lonon welcomed the Board to the Arts Council. She announced that the beautiful artwork on display "Young at Art" was created by Ashe County K-12 students and home-schooled students. Mrs. Lonon briefed the Board on the programming offered at the school level, thanked all visual arts and choral teachers for their dedication, and expressed appreciation to the Board for continued support in the arts.

The May ACS Employee of the Month Award will be presented to April Blevins, Receptionist at Ashe High, at the next regular meeting of the Board. Mrs. Blevins was unable to attend due to illness.

Superintendent Reeves and Personnel Director Lesia Nave recognized Jessica W. for receiving the 2010 Teaching Fellows Award and presented her with a certificate for this achievement.

Superintendent Reeves and Personnel Director Lesia Nave recognized Laura Bowers, Media Specialist at Westwood, for receiving the University of North Carolina at Greensboro 2010 Outstanding Achievement Alumni award and presented her with a certificate for this achievement.

A motion by Mr. Jones and a second by Mrs. Witherspoon gave unanimous approval to a request from Matthew and Lisa Wilcox, who reside in Ashe County, to allow their son Drew Wilcox, to attend school in Watauga County effective school year 2010/11.

Superintendent Reeves and Maintenance Director Kenneth Richardson presented an update on longrange planning and facility needs for five-year and ten-year projections. Superintendent Reeves and Assistant Superintendent of Finance Phyllis Yates presented to the Board a detailed summary of state funding projections per Governor Perdue's proposal for fiscal year 2010/11 (as of 4/20/2010). Superintendent Reeves stressed the importance of contacting legislators regarding the negative impact these proposed budget cuts will have on Ashe County Schools.

A motion by Mr. Jones and a second by Mrs. Witherspoon gave unanimous approval to the following resolution to establish Fund 8.

#### RESOLUTION

#### ESTABLISHMENT OF FUND 8

WHEREAS the North Carolina Department of Public Instruction and the Local Government Commission have approved the establishment of a new fund, designated as Fund 8, into which LEAs may deposit monies designated for restricted purposes and not intended for the general K-12 student population.

NOW, THEREFORE, the Ashe County Board of Education hereby authorizes the transfer into Fund 8 those funds currently in Fund 2 that are designated for restricted purposes and not intended for the general K-12 student population.

A motion was made by Mrs. Witherspoon and a second was made by Mr. Jones to accept the 2010/11 School Calendar. After much discussion, Mrs. Witherspoon amended her motion to approve the 2010/11 School Calendar as proposed with Ashe High being a pilot for the enrichment days (December 20, 21,22) and allowing Superintendent Reeves to use his discretion as to which elementary school would also participate in the pilot. A second was made by Mr. Jones giving unanimous approval to the 2010/11 School Calendar.
