MINUTES

ASHE COUNTY BOARD OF EDUCATION

March 7, 2011

The March meeting was held as scheduled in the Board of Education Annex with all members present. Vice Chairman Jones arrived slightly late due to his work schedule. Chairman King called the meeting to order, welcomed those in attendance and led the Pledge of Allegiance.

The agenda for the meeting was approved by general consensus.

Superintendent Reeves presented the March Ashe County Schools Employee of the Month Award to Ronald Turnmire, lead custodian at Ashe Middle.

Dr. Beckworth presented a certificate to Katie O., Ashe County's 2011 Spelling Bee champion. He wished her success at the regional level this weekend in Winston-Salem. Katie is a 7th grade student at Ashe Middle. Dr. Beckworth also presented the school trophy to Principal Pennington to display at the school.

Teachers Keana Triplett and Pat Morrison, along with BETA club students, described the awards they received at the State Beta Club Convention in Greensboro, North Carolina.

Following a change in wording in the last paragraph on page 4 of Policy 3540 Comprehensive Health Education Program to read **removing** rather than **inserting** and the addition of discussion of personnel [N.C. General Statute §143.318.11(a)(6)] to closed session, a motion by Dr. Beckworth and a second by Mr. Williams gave unanimous approval to the minutes for the regular meeting of the Board on February 7, 2011.

A motion by Vice Chairman Jones and a second by Mr. Williams gave unanimous approval to the Resolution Opposing Senate Bill 8 which will be sent to Governor Perdue, County Commissioners, Representative Jordan, and Senator Soucek. Mrs. Jones suggested that a copy be sent to everyone on the committee as well.

A motion by Mrs. Jones and a second by Dr. Beckworth gave unanimous approval to the request from a student to graduate early.

A motion by Dr. Beckworth and a second by Vice Chairman Jones gave unanimous approval to a request from Ashe High AP environment science class for an overnight trip to Mt. Mitchell, March 25-26, 2011.

A motion by Mr. Williams and a second by Dr. Beckworth gave unanimous approval to a request from Ashe High AP environment science class for an overnight trip to Stone Mountain, May 20-21, 2011. (This item was not on the initial agenda.)

A motion by Vice Chairman Jones and a second by Mrs. Jones gave unanimous approval to a request from Blue Ridge Odyssey of the Mind teams for an overnight trip to attend the state competition in Asheville, April 1-2, 2011.

A motion by Dr. Beckworth and a second by Mrs. Jones gave unanimous approval to a request from Laura Bare, who resides in Ashe County, to allow her son to attend school in Alleghany County effective immediately.

Blue Ridge Elementary 4th grade teacher Travis Richardson demonstrated the varying uses for flip cameras during the segment on *Tech Talk*. .

Retired teacher Claudine Silver reported on the *Growing Gardeners Project*, an endeavor to teach gardening skills to students. The project will partner elementary and high school students. Elementary students will be responsible for planting warm weather crops, and the high school agriculture class will be responsible for tending and harvesting the crops. Ms. Silver stated that this school system is the best she has ever seen and expressed congratulations for the job being done. She asked the Board for their continued support.

Rebecca Herman of the Ashe Arts Council reported on the importance of arts programming in the schools. Cameron Current, parent, spoke about the impact the arts had on him when he was in school, followed by his children sharing art they had created at school.

Superintendent Reeves reported on the new regulations tied to receiving revenues from the ABC Board. The State ABC Board is now requiring that schools incorporate alcohol education in the classroom. Due to requirements of the standard course of study, it will be difficult to implement into the curriculum except at the middle school—the program can be implemented during the discovery block. In the past, the school system has used its pro-rata share of revenues for materials targeting at-risk students. The complete curriculum program for the middle school would cost approximately \$5,000. Mr. Williams stated that this seems to be the appropriate age level to target. CFO Phyllis Yates is to contact the local ABC Board to see if this plan would meet the criteria to receive full funding.
