MINUTES

ASHE COUNTY BOARD OF EDUCATION

February 6, 2012

The February meeting was held at the Board of Education annex as scheduled with all members present. Chairman King called the meeting to order, welcomed those in attendance and led the Pledge of Allegiance.

The agenda for the meeting was approved by general consensus.

During open comments, the Ashe Arts Council parent group STAE, <u>Support Team</u> for <u>Arts Education</u>, sung a song to the tune of Frere Jacques which highlighted the importance of keeping arts programming in the schools.

Superintendent Reeves recognized and presented a posthumous award to the *February Employee of the Month* Fred Absher, bus driver at Westwood, who passed away on January 1, 2012. The family was present to accept the award.

Superintendent Reeves recognized the following individual school *Teacher of the Year* nominees and presented each with a certificate acknowledging their achievement: Sarah Tugman, Ashe High; Teresa Hughes, Ashe Middle; Richard Gill, Blue Ridge; Colleen Dixon, Mountain View; and Sherry Phillips, Westwood. Dr. Reeves then recognized Ashe High teacher Sarah Tugman as the *2011/12 Ashe County Schools Teacher of the Year* and presented Mrs. Tugman with a plaque acknowledging her achievement.

Teresa Stansberry, Director for Exceptional Children, recognized Ashe Middle teacher Holly McClure as the 2011/12 Teacher of Excellence for Exceptional Children. Superintendent Reeves presented Mrs. McClure with a certificate recognizing her achievement.

The Superintendent recognized Jennifer Robinson, principal at Westwood, as the 2011/12 Ashe County Schools Principal of the Year and presented her with a plaque acknowledging her achievement.

The Superintendent recognized the following recipients of the 2011 National Board for Professional Teaching Standards (NBPTS) certification and presented each with a certificate acknowledging their achievement: Dedra Buchanan, Blue Ridge; and Jana Baldwin, Eva Lucinda Jackson, Jamie Little and Robin Nethery, Mountain View.

Following an in-depth discussion on the criteria for employing a football coach at the high school, a motion by Mr. Williams and a second by Dr. Beckworth gave unanimous approval to begin the search for the best possible teacher/coach.

A motion by Dr. Beckworth and a second by Mrs. Jones gave unanimous approval to adopting both the calendar for 185 instructional days and the calendar for 180 instructional days as prepared by the 2012/13 School Calendar Committee. The official calendar will later be determined by whether or not the General Assembly grants a waiver of the five (5) additional days legislated in House Bill 200. If a waiver is approved, these five days will be designated as required teacher workdays and used to strengthen implementation and integration of the Common Core/Essential Standards.

A motion by Mrs. Jones and a second by Vice Chairman Jones gave unanimous approval to paying a stipend to ten-month certified employees from Race to the Top funds for committee leadership and attendance at the local Summer Conference for Common Core/Essential Standards.

Wesley Roten and Amanda Tugman, students at Ashe County High School, gave a presentation on the *Dick Miller Youth Leadership Program*. The program is sponsored by the Ashe County Chamber of Commerce in cooperation with the North Carolina Cooperative Extension, Ashe County Center, and Ashe County Schools. The goal of the program is to empower students to become responsible civic leaders in their community by exposing them to the basic organization of a community—government, business, environment, legal, media, civic, volunteer, etc.—and how these groups interact. On behalf of all the students involved in the program, Wesley and Amanda stated that the group was very appreciative of the opportunity to participate in the program and that it had proved to be a worthwhile learning experience.

Roman Gabriel, III, was scheduled to give a presentation on his *Sold Out Drug and Alcohol Awareness Program*, but did not get back from Indianapolis, Indiana in time to do so. The Superintendent, who had met with Mr. Gabriel on two occasions, explained that the program will be funded through private donations and that professional athletes will speak to high and middle school students during assembly programs. Mr. Gabriel has also met with the high school and middle school principals. Although the program has a very positive message, the Board felt that the program must be secular in nature and that at least one student assembly be held before allowing access to students through Facebook. Mr. Gabriel will be rescheduled for the March meeting.

On Tuesday, January 31, Ashe County Schools was invited to participate in a round-table discussion with the North Carolina State Board of Education members and advisors. The State Board invited one four-person team from each of State's eight educational regions. The designation of team members was very purposeful, in that they wanted to hear and value the perspectives of the various roles. The four-person team from Ashe County included the Superintendent, Chairman King, Principal Jason Krider and High School Math Teacher Carmen Wilson. The purpose of the round-table discussion was to help the State Board and its advisors gain insight on the most critical issues impacting public education as perceived by each of the regions. Chairman King, along with other team members, felt that the meeting was very worthwhile.
