# ASHE COUNTY BOARD OF EDUCATION

September 10, 2012

The September meeting was held at the Central Office Annex as scheduled with all members present. Chairman King called the meeting to order, welcomed those in attendance and led the Pledge of Allegiance.

Human Resource Director Lesia Nave informed the Board that the second item under the cafeteria assistants in the personnel section had been included in error and asked that it be removed. The agenda was then approved by general consensus of the Board.

Superintendent Reeves reviewed the Memorandum of Agreement between Ashe Outreach Ministries and Ashe County Board of Education for expansion of kitchen services at the West Jefferson site (AWLC). The Board asked that the vote be moved to the October meeting to allow more time for review and discussion of the Memorandum.

Human Resources Director Lesia Nave discussed a recent revision to Policy 6125 Administering Medicines to Students. Amy Quesinberry, Northwest Region School Nurse Consultant, discussed the need for having EpiPens available to administer to students who have not been identified as having a

food or any other type of allergy in case they have a life-threatening anaphylactic reaction. Lead Nurse Tammy Craine feels if personnel are trained by a physician to identify the symptoms of a life-threatening anaphylactic reaction, they may safely administer an EpiPen. Dr. Bradley has agreed to conduct the training. Vice Chairman Jones is in support because he sees it every day and knows the importance of having a quick response. Dr. Beckworth questioned the legality of administration of the medicine and the need for parental consent. Board Attorney Fred Johnson advised the Board of Education on a liberal interpretation and a conservative interpretation of the legality of administering the medicine. Superintendent Reeves will consult with Mr. Johnson further to see if there is more of a liability with or without parental consent.

Superintendent Reeves provided an update on 2012 Education Legislation.

- Ashe County will host the NCSBA District 7 meeting in 2013. Chairman King has agreed to serve as
  the Vice President for District 7 in 2012 and President for District 7 in 2013. At the meeting on
  September 26, Mr. King will deliver the greetings and extend an invitation to the 2013 meeting
  hosted by Ashe County.
- Superintendent Reeves has been elected Vice Chairman of Region 7 Superintendents' Council.
- The next regular meeting of the Board is scheduled for Monday, October 1, 2012, 7:00 pm, at the central office annex.
- Visit by State Board Chairman Dr. Bill Harrison, Friday, September 28
- Lesia Nave has been elected to serve as Vice President of PANC.

A motion at 8:15 pm by Vice Chairman Jones and a second by Mr. Williams gave unanimous approval to a short recess prior to going into closed session for the purpose of considering a personnel action that involves an officer or employee of this Board [N.C. General Statute §143.318.11(a)(6)], real estate [§143.318.11(a)(5)], and student matter [§143.318.11(a)(1)].

The Board went into closed session at 8:25 pm and returned to regular session at 10:30 pm.

Upon return to regular session, a motion by Dr. Beckworth and a second by Vice Chairman Jones gave unanimous approval to accepting the resignation of Megan Lancaster as teacher assistant for exceptional children at Westwood effective September 14, 2012.
