MINUTES ASHE COUNTY BOARD OF EDUCATION September 9, 2013

The September meeting was held at the Central Office Annex as scheduled with all members present. Chairman King called the meeting to order, welcomed those in attendance and led the Pledge of Allegiance.

Following a change in the order of business, the agenda was approved by general consensus of the Board

During open comments, members of the Ashe County Arts Council, Judy Dancy, Connie Hardison and Martin Little, welcomed in the new school year to the tune of *Home on the Range*.

Superintendent Holden recognized Mountain View Elementary as a *Title I Reward School for 2013/14* and Vice Chairman Jones presented the school with a certificate. Principal David Blackburn and Tina Key accepted on behalf of the school.

Transportation Director Shea Coldiron recognized the following bus drivers for perfect attendance in 2012/13:

Following deletion of the next to last paragraph regarding Policy 7241 which had already been approved at the June 28, 2013 meeting, a motion by Dr. Beckworth and a second by Vice Chairman Jones gave unanimous approval to the minutes for the regular meeting of the Board on August 5, 2013.

A motion by Vice Chairman Jones and a second by Mr. Williams gave unanimous approval to a request from Ashe County High JROTC for an overnight trip to the Lost Sea in Sweatwater, TN, November 23-24, 2013.

A motion by Mr. Williams and a second by Dr. Beckworth gave unanimous approval to a request from Ashe County High Chorus for an overnight trip to attend the Gardner-Webb Choral Clinic, October 9-10, 2013.

A motion by Vice Chairman Jones and a second by Mrs. Jones gave unanimous approval to entering into a oneyear contract with NC Driving School to deliver the driver education curriculum at no cost to students as presented by Associate Superintendent Phyllis Yates.

Superintendent Holden provided an update on the attendance policy in relation to make-up time as approved at the June 2011 Board meeting. The School Improvement Team at the high school has decided on time-for-time makeup before and after school.

Amy Walker, Alisa Taylor, Callie Grubb and Cathy Gentry introduced Board members to Smarter Balance online assessments. The team highlighted the complexity of these assessments and expressed the need to make additional wireless devices available for student instruction and interaction.

Human Resources Director Lesia Nave presented a draft of the policies/procedures on the Code of Ethics for certified and non-certified staff. Dr. Beckworth felt that the wording under item numbers 3 and 10 is too threatening and asked that it be changed.

Jamie Little, K-6 Curriculum Coordinator, gave a presentation on the 2013/14 K-12 Writing Assessment Plan. The purpose of this assessment plan is to ensure that all Ashe County students will be prepared with the writing skills needed to be 21st century ready. Revision of this plan also aligns with the more rigorous Common Core state standards.

Associate Superintendent Phyllis Yates informed the Board of the 2013 rate adjustment notice from Blue Ridge Electric Membership Corporation. The overall 2.5 percent adjustment will become effective with the October billing. Mrs. Yates also informed the Board that she had been notified by First Citizens that the bank is increasing its monthly service fee from \$150 to \$450 per month.

Human Resources Coordinator Marcia Elledge gave an update on contracting with Background Investigation Bureau (BIB) for drug screening and back ground checks, which should save the school system approximately 22 percent.

Dr. Holden informed the Board that he and his staff are exploring the pros and cons of the school system having a Facebook page.
