MINUTES ASHE COUNTY BOARD OF EDUCATION March 3, 2014

The March meeting was held at the Central Office Annex as scheduled with all members present. Chairman King called the meeting to order and welcomed those in attendance. The Pledge of Allegiance was led by Scout Troup 214 under the leadership of Troop Leader Trey Simmons.

Maintenance Director Kenny Richardson gave an update on the State's approval of the Panic Alarm Grant. The matching dollar for dollar grant was approved in the amount of \$8,146. Panic alarms will be installed at all the schools and the Early Learning site by June.
