MINUTES ASHE COUNTY BOARD OF EDUCATION March 7, 2016

The meeting was held as scheduled with all members present. Chairman King called the meeting to order, welcomed those in attendance and led the Pledge of Allegiance.

Following the addition of a personnel item, the agenda was approved by consensus of the Board.

A motion by Dr. Beckworth and a second by Mrs. Jones gave unanimous approval to the minutes for the regular meeting of the Board on February 1, 2016.

The Superintendent led discussion on naming Ashe County's teacher of the year award in honor of Oddie Cox. In recognition of Black History Month, two students, Justin Blevins and Jared Richards, along with instructor Josh Beckworth, from the Appalachian Studies class at Ashe High, presented this idea to the Board at its February meeting. Mr. Cox, a well-respected and accomplished teacher in the early 1900s, was an excellent role model for young people. He was responsible for lobbying the school board to build the first consolidated black school, a four-room building in the Bristol Community. Former retired school administrators Sam Shumate and Morris Walker relayed to current Board members that this honor was "long overdue—Mr. Cox gave to young people so they would have a better life." A motion by Vice Chairman Jones and a second by Mr. Williams gave unanimous approval to naming Ashe County's teacher of the year award in honor of Mr. Oddie Cox.
