MINUTES ASHE COUNTY BOARD OF EDUCATION April 11, 2016

The meeting was held as scheduled at the Ashe Arts Council with all members present. The Chairman called the meeting to order, welcomed those in attendance and led the Pledge of Allegiance.

New items were added to the agenda—additional personnel recommendations and a request for an overnight trip from the middle school to attend the State Envirothon competition. The agenda was approved by general consensus.

During open comments, Arts Council Director Jane Lonon thanked the Board for its support of arts education and pointed out the K-12 Annual Young at Art Exhibit showcased around the room. She gave an overview of the upcoming arts programs on April 16—the Very Special Arts Festival and Spring Fest. Mrs. Lonon commended the school system for its stellar art programs. The partnership between the schools and Arts Council sponsored 46 performances for students to enjoy this school year.

Dr. Beckworth recognized Miguel G., 8th grade student at Ashe County Middle, as the 2016 Ashe County Spelling Bee Champion and presented Miguel with a certificate and trophy. Miguel was also the 2015 County Spelling Bee Champion.

The Board recognized the 2015/16 Dick Miller Youth Leadership participants. On behalf of all the participants, students Keely Caddell and Tori Colvard spoke on the many benefits they gleaned from participating in the program and thanked the Board for its support.

Karee Mackey, the Gear Up Coordinator for Ashe County, gave an overview of the Gear Up grant through Appalachian State University that focuses on college awareness and readiness undergraduate programs. The program grant, which began with grade 6 in February 2015, will track this cohort of students through graduation from high school. Gear Up actively encourages students to set high academic expectations and offers an array of opportunities which enables students to increase their knowledge of educational options beyond high school.

Marcia Elledge, the Board Liaison to the Endowment Committee, gave an overview of the 2016 Ashe County Schools Endowment Grant Awards. The Grant Committee awarded a total of \$11,906 to 16 of the 20 grants submitted. A motion by Mrs. Jones and a second by Vice Chairman Jones gave unanimous approval to the disbursement of grant monies. The recipients will be recognized at the May meeting of the Board.

A motion by Mr. Williams and a second by Dr. Beckworth gave unanimous approval to the proposed 2016/17 School Calendar as presented by the Superintendent and the School Calendar Committee.

A motion by Dr. Beckworth and a second by Vice Chairman Jones gave unanimous approval to the transmission line easement agreement with Blue Ridge Electric Membership Corporation. The easement is located on the Ashe County Middle School property.

The Superintendent expressed appreciation to the Ashe Arts Council for its commitment to the students of Ashe County.

Superintendent Holden submitted his resignation as Superintendent of Ashe County Schools effective July 1, 2016 to take a superintendent's position in Madison County. Dr. Holden stated that this was a very difficult decision and expressed appreciation to the Board and staff for their support.
