A motion by Vice Chairman Jones and a second by Mrs. Jones gave unanimous approval to the following Resolution for Interim Appropriations for fiscal year 2016/17.

BE IT RESOLVED that the Chief Financial Officer for the Ashe County Board of Education be, and hereby is, authorized to continue paying salaries and the usual, ordinary expense in amounts not to exceed those set in the current budget period. This authorization is to be effective from July 1, 2016 until the adoption of a new budget resolution pursuant to North Carolina G. S. 115C-434. Any such interim appropriations expended shall be charged to the proper appropriation in the 2016/17 budget upon adoption.

CTE Director Joallen Lowder gave a comprehensive overview of the Cooperative Innovative High School Program (CIHS) as authorized through legislation—GS 115C-238-50. The overall purpose for the legislation is

to provide funding for cooperative innovative programs jointly in high schools and colleges or universities that will expand students' opportunities for education success through high quality instructional programming. Ashe County Schools would partner with Wilkes Community College thereby enabling students to concurrently obtain a high school diploma and begin or complete an associate degree program, master a certificate or vocational program, or earn up to two years of college credit within five years. A motion by Terry Williams and a second by Vice Chairman Jones gave unanimous approval to submitting a Cooperative Innovative High School application by September 15, 2016. If approved at the State level, the school would open in the fall of 2017.

Associate Superintendent Yates gave an update on the Employee Census data audit for the year ended December 31, 2015. The independent auditor's report as performed by Anderson Smith & Wike examined the employee census data and related underlying payroll records of the school system to determine that the employee census data provided to the Teachers' and State Employees' Retirement System was complete and accurate. The auditing firm found that the employee census data to be accurate based on the criteria set by the Retirement System.
