# MEETING ASHE COUNTY BOARD OF EDUCATION November 5, 2018

The meeting was held as scheduled with all members present. Chairman Jones called the meeting to order, welcomed those in attendance and led the Pledge of Allegiance.

Following an addendum to personnel, the agenda was approved by general consensus.

Lesia Goodman, Director of Human Resources, recognized Jill Gambill as the North Carolina Art Education Association Middle Level Art Education Teacher of the Year for 2018/19. The Art Education Association also recognized Ms. Gambill in Asheville last weekend for her accomplishment.

Band Director Paula Carlton recognized the Husky Vanguard Marching Band for their Superior ratings during the competition season. She brought the section leaders with her to receive the certificate from the Board on behalf of the Band.

Principal Elaine Cox expressed public appreciation to the Board for attending the Ribbon Cutting Ceremony for Ashe Early College on October 26, 2018. She remarked that students were pleased that the Board attended and was impressed at how many people attended overall.

A motion by the Vice Chairman and a second by Mrs. Jones gave unanimous approval to revisions to the tardy procedures for Policy 4400 as presented by Jamie Little, Director of Student Services.

Maintenance Director Jerry Baker gave an update on the athletic field at Ashe High. Grading is now complete—the new field has almost the same usable space as the old field. Mr. Baker presented the estimated costs for seeding, irrigation and fencing for the Board's consideration.

The Superintendent gave an update on attendance at the Parent/Teacher conferences for each of the schools—Ashe High at 4 percent, Ashe Early College at 66.6 percent, Ashe Middle at 37 percent, Blue Ridge at 74 percent, Mountain View at 53.23 percent and Westwood at 78.5 percent.

The Board selected the week of December 10 to have the training session on duties and responsibilities for Board members—ethics will also be included in the training. This training also requires the attendance of all school-based and district administrators. The Superintendent is to contact the trainer.

Board Member assignments were made for American Education Week November 12-16. Chairman Jones will attend the receptions at Ashe Early College and Ashe High, Vice Chairman Beckworth will attend the receptions at Blue Ridge and Ashe Middle and Mrs. Jones will attend the receptions at Mountain View and Westwood. Mr. Williams will not be in town that week.

The Superintendent reported that she was invited to attend the County Commissioner meeting at 9:00 am on this date. The Commissioners approved the plans for the middle school project, thereby allowing

Architect Larry Greene to move forward in preparing the plans for bid. Commissioner McNeill reiterated that the Commissioners made sure that the principal was happy with the plans before giving final approval. The Superintendent expressed appreciation to the Commissioners for its support.
