MINUTES ASHE COUNTY BOARD OF EDCUATION March 5, 2018

Due to the number of attendees, the meeting was moved to the auditorium at the high school. March has been officially designated by the National Association for Music Education for the observance of *Music in Our Schools Month*, so the high school's Steel Band provided entertainment in the Commons area prior to the meeting. AppHealth Director of Community Health Services Maria Julian and Student Services Coordinator Jamie Little gave an update on the results of the Youth Risk Behavior Survey (YRBS). The nationwide survey was administered in the Spring of 2016 to all students in grades 6-12 and is used to measure all areas of student health and wellness. The results of the survey indicated a few highlights that were vast improvements over the last survey conducted two years ago—decreased suicidal thoughts and attempts; decreased alcohol, tobacco and other drug use; and decreased risky dietary practices. Areas of concerns included increased video gaming and computer use and fewer students eating breakfast. Overall, it appears that the areas focused upon as a result of the previous YRBS have produced positive results. The report will be highlighted in the upcoming Community Health Report.

The Superintendent reported that school safety has always been a top priority of the Ashe County Board of Education and its administrators. Following the recent tragedy in Florida, school safety has become a major topic of conversation both at the local and national level. Although the school system does have a safety plan in place, a committee composed of educators, law enforcement officials, emergency management experts, parents and students has been organized to contribute ideas for preventing and responding to safety concerns. Through organized conversations, the Safe Schools Committee will analyze, dissect and design measures and tactics to ensure student and staff safety within the school system. This Committee will begin meeting in the near future.

The Superintendent reported that the middle school baseball team can now use the Ashe Aces practice facility in Laurel Springs when the weather is bad. The facility is owned by Bow and Rusty Estes.

The 2018/19 budget work session was scheduled for Tuesday, March 27, 2018, beginning with a dinner meeting at 5:00 pm.
